Honours and Awards

This is a reminder that the Honours and Awards nomination deadline is approaching. CAIRP encourages you to submit nominations for the following awards:

Fellowship Award - Deadline April 30, 2017

The Association's highest award to members who have given exemplary service and brought distinction to the profession and the Association.

Keith G. Collins Award - Deadline April 30, 2017

This award is given to an individual who has displayed Keith's positive attributes of integrity, courtesy and professionalism; someone respectful of others, unpretentious and who shows the willingness to mentor and share knowledge and demonstrate community service.

New Members Award of Merit - Deadline April 30, 2017

The New Member's Award of Merit recognizes a new member (someone who has obtained their CIRP within the past five years) who demonstrates outstanding excellence in their profession through volunteer leadership in CAIRP and/or volunteer service in other community organizations.

Outstanding Volunteer Award – Applications can be presented at any time (no form necessary)

This award is given to someone who has given exceptional volunteer service to the Association through one or more specific activities and/or provided continuous support to the Association.

Update on OSB Licence Administration Application (OLAA)

The Office of the Superintendent of Bankruptcy (OSB) is moving from a paper-based process for administration of Licensed Insolvency Trustee licences to an online model.

The OSB Licence Administration Application (OLAA) is a web-based, self-serve interface for trustee candidates and LITs that will allow for completion of common license administration tasks online. LIT candidates for the 2017 Oral Boards will be applying online this year and will use the application to track the status of their request.

Later this year, more features will be added, allowing all LITs to view, update and maintain administrative licence information; pay licence fees; and submit requests for changes, both for individual and corporate licences. The application will also include an enhanced Licensed Insolvency Trustee Directory, making it easier for consumers to find an LIT in their area.

Watch for the new OSB Licence Administration Application rolling out this year.
